Internship Program Structure

Phase 1: Orientation & Core Foundations

- Orientation: Introduction to Halal Research Council and the global significance of Halal certification for food, nutrition, and FMCG sectors.
- Core Principles: Halal vs. Haram fundamentals, the role of the Shariah Supervisory Board, and key certification standards across different product categories.
- Global Landscape: Comparative analysis of major Halal standards (ASEAN, GCC, OIC/SMIIC) and the key international regulatory and accreditation bodies.

Phase 2: Practical Application & Audit Simulation

- Case Study Deep Dives: Analyze complex certification scenarios for multinational brands in food, cosmetics, and pharmaceuticals.
- Audit Simulation: Participate in a simulated product certification audit, working through the steps of ingredient verification, supply chain mapping, and facility assessment.
- Compliance Assessment: Conduct a mock review of a product formulation to assess its compliance against a specific international Halal standard.

Phase 3: Professional Skill Development

- Awareness Campaign: Develop and execute a social media initiative to educate consumers on the importance and process of Halal certification.
